	Programme for Government Commitment	Progress
<b>Provide effective, high quality and sustainable healthcare</b>		
1	Establish a new medical school in North Wales.	The North Wales Independent Medical School Programme Board has been established and will build upon the work of the North Wales Medical School Task and Finish Group. A significant amount of work has already been undertaken with Cardiff University to develop the provision to progress through the necessary General Medical Council accreditation process as quickly as possible.
2	Provide treatments which have been delayed by the pandemic.	<i>Our programme for transforming and modernising planned care and reducing waiting lists in Wales</i> was published on the 26 April, setting a series of stretching targets for health boards. The plan is backed by an additional £170m a year of funding.  2021-22 saw a reduction in the rate of growth of the long waits (over 36 weeks) compared to 2020-21. The amount of inpatient and day case activity in 2021/22 was 246,146 This was 95,638 (64%) higher than 2020/21. There were 2,876,571 outpatient appointments, this was 836,071 (41%) higher than in 2020/21, closer to pre-pandemic levels. Waits over the 8-week target for diagnostic tests in March 2022 reduced back to a comparable level to March 2021 after increasing during the year.
3	Deliver better access to doctors, nurses, dentists and other health professionals.	Additional online ways to access medical and health advice in the community, including eye care, have been introduced. A national programme to transform access to allied health professionals has been funded and work is on-going with the dental profession to reform dentistry. The national General Medical Services contract has introduced a commitment to help ensure GP practices release appointments throughout the day. In addition, the 111 telephone service is now available across Wales.
4	Reform primary care, bringing together GP services with pharmacy, therapy, housing, social care, mental health, community and third sector.	The Accelerated Cluster Development (ACD) Programme has launched to strengthen clusters as the mechanism for bringing local health and care services together to plan and deliver services matched to the needs of individuals and communities. A roadmap for delivery in 2022/23 has been sent to NHS Chairs, Leaders of local authorities and Regional Partnership Board Chairs.
5	Prioritise investment in mental health.	This commitment has been completed by prioritising mental health and wellbeing in the 3-year budget settlement, allocating an additional £100m up to 2024-25. This included an additional £50m in 2022-23, including £20m to support mental health service improvements and the implementation of the Mental Health Workforce Plan. As a result of this investment, in 2022-23 alone, the ring-fenced mental health budget being provided to local health boards will be over £760m. This will support the recovery, development and transformation of services including CAMHS, crisis / out of hours and perinatal mental health services. Further support will also be available for all-age eating disorder services, primary care liaison and further development of tier 0/1 services.

6	Prioritise service redesign to improve prevention, tackle stigma and promote a no wrong door approach to mental health support.	<p>The NEST/NYTH framework has been developed and provides a planning framework for Regional Partnership Boards (RPBs) to develop a whole system approach to developing mental health and well-being support. RPBs have been requested to develop detailed implementation plans and the Together for Children and Young People programme has worked with and will support RPBs in developing and implementing these plans from April 2022. The framework was specifically built into the £144.6m a year Regional Integration Fund to ensure RPBs could use this transformative resource as a lever for wider core resources in order to establish sustainable, integrated models of care for the future.</p> <p>Health boards are on track to implement 24/7 single points of contact for urgent mental health issues later in 2022/23. The service will operate via 111, press 2 for mental health and will provide immediate support from a mental health practitioner. Health boards are also making progress in transforming CAMHS services with the implementation of Single Points of Access as part of the wider 'no wrong door' approach.</p>
7	Roll out child and adolescent mental health services 'in-reach' in schools across Wales.	Additional funding has been made available for children and young people's mental health provision including £5m in 2021-22 for the extension of the Child and Adolescent Mental Health Services (CAMHS) school in-reach pilots. This followed publication of the final evaluation of the pilots. Local Health Boards anticipate services will be fully operational from March – September 2022, almost £16.5m will be invested in developing and maintaining the service over the next three years.
8	Introduce an all-Wales framework to roll out social prescribing to tackle isolation.	Through engagement with almost 1,000 stakeholders, a draft Welsh model of social prescribing has been developed and a number of key themes identified. In order to embed social prescribing across Wales and to ensure consistency of delivery at a local level, a consultation exercise will be held over the summer to explore what standards, guidance and actions are needed as part of a national framework for social prescribing.
9	Review patient pathway planning and hospice funding.	The review of voluntary hospice funding is now complete, and the recommendations accepted. An additional £2.2m has been provided on a recurring basis from April 2022.
10	Develop an HIV action plan for Wales.	Work on the HIV Action Plan has begun and an HIV Action Plan Group (HIVAPG) comprising a range of stakeholders including clinicians, representatives of the voluntary and community sectors, Public Health Wales, academia and expert patients living with the disease has been established to inform its development. In June 2022, we published a consultation on the draft plan which has been co-produced with organisations, experts and people with lived experience.
11	Introduce an autism statutory code of practice on the delivery of autism services.	<p>The Code of Practice came into effect on 1 September 2021 completing this commitment.</p> <p>An independent demand and capacity review of all-age Neurodevelopmental (ND) services was completed in March 2022. A further survey on the experiences of children and adults accessing support and services was undertaken between March and May 2022.</p>

12	Pay care workers the real living wage and working with social partners through the Fair Work Forum consider further steps towards parity of recognition and reward for care workers.	<p>Following advice from the Social Care Fair Work Forum, £43m of funding was made available to local authorities and Health Boards to roll-out the Real Living Wage for eligible care workers from April 2022.</p> <p>Guidance has been developed in partnership with stakeholders to deliver a consistent approach to implementation of the Real Living Wage to care workers.</p> <p>In addition to this, we announced a one-off payment of £1,498 (gross) to social care workers, who are eligible for the Real Living Wage, to demonstrate our commitment to improving the status, terms and conditions, and career pathways for social care workers.</p>
13	Increase apprenticeships in care and recruit more Welsh speakers.	<p>Work continues with Social Care Wales and wider sector stakeholders including social care employers to identify barriers and opportunities to growing apprenticeships in care.</p> <p>Media campaigns have been delivered under the 'Genius Decision' banner and subsequently through Social Care Wales's successful WeCare Wales brand. These are aimed at promoting apprenticeships in social care and roles in the social care sector including to Welsh language speakers.</p>
14	Establish an expert group to advise by April 2022 on the practical steps towards delivering a national care service that is free at the point of need.	The Expert Group has been established and met for the first time in February 2022. It will provide recommendations on the practical steps to create a National Care Service. The Expert Group is made up of individuals from a range of backgrounds, including those with experience in social care, finance, economics, academia, and healthcare.
15	Legislate to further integrate health and social care services.	<p>The <i>Rebalancing Care and Support White Paper</i> detailed a series of transformative proposals for Social Care. Work is underway on further integration including the launch of the £144.6m a year Regional Integration Fund to establish six National Models of Integrated Care. The Regional Integration and Rebalancing Capital Fund will support the development of Integrated health and social care hubs.</p> <p>Co-production and partnership are central to the delivery of the Regional Rebalancing Programme and five regional Task and Finish groups have been established to oversee its delivery.</p>
16	Support innovative housing development to meet care needs.	Through the Housing with Care Fund (HCF) capital programme, £60.5m per annum (for at least three years from 2022-23) has been allocated to fund specialist low carbon social homes and accommodation for people with care and support needs. The HCF builds on the Integrated Care Fund (2018-2022), which invested in 50 housing schemes, 66 intermediate care projects, and a range of integrated hubs and facilities.
17	Fund childcare for more families where parents are in education and training or on the edge of work.	The Childcare Offer for Wales will be expanded from September 2022. This expansion will enable parents of 3 and 4-year-olds in education and training to access up to 30 hours of government funded early education and childcare per week for 48 weeks per year, on the same footing as eligible working parents. Alongside this, work to raise awareness of other programmes of support with childcare costs for parents in education and training will be developed.

A phased expansion of early years provision to include all two year olds, with a particular emphasis on strengthening Welsh-medium provision will start from September; £60m has been allocated over the next three years to support delivery of this commitment.
19	Continue to support our flagship Flying Start programmes.	Support is continuing for the Flying Start programme with an additional £15m invested over the next three years.
20	Prevent families breaking up by funding advocacy services for parents whose children are at risk of coming into care.	A framework and service criteria that will support the delivery of consistent advocacy services delivery across Wales is being developed with partners. Funding arrangements to support delivery have been agreed from April 2022. Funding will focus on growing existing regional supply, the development of the national framework and encouraging a consortium-based approach to enable additional capacity to be developed before extending delivery to other regions.
21	Provide additional specialist support for children with complex needs who may be on the edge of care.	Through the Integrated Care Fund and Regional Partnership Boards work has focused on identifying and investing in projects and new approaches that benefit children with complex needs, such as disability and emotional/behavioural needs, which will enable children to remain in the care of their families. 28 projects have been identified to date, including Early Help Hubs and the ICEBERG Project to promote children's positive mental health across multiple environments.
22	Explore radical reform of current services for looked after children and care leavers.	An Oversight Board has been established to drive transformational change in children's services. The Board is working collaboratively with the sector on peer learning and professional development and supporting a systems-wide approach to improving quality and services. £3m funding has been identified to support the delivery of the Radical Reform agenda.  As part of the wider transformation of Social Care, the Board is advising on the children's elements of the National Care Framework. The Board will develop a National Practice Framework for children's services that will deliver greater consistency across Wales.
23	Eliminate private profit from the care of children looked after.	A multiagency Programme Board has been established to support work focussing on building placement sufficiency, supporting the transition to not-for-profit models, defining profit, and informing our legislative approach.  £10m a year for the next three years has been made available to assist local authorities and existing not-for-profit providers to scale up existing provision, develop placement capacity, protect against market instability.
24	Fund regional residential services for children with complex needs ensuring their needs are met as close to home as possible and in Wales wherever practicable.	Funding was identified in 2021-22 to pump prime support for the development of regional residential services for children with complex needs in all the Regional Partnership Boards (RPBs) areas. Subsequently £4.8m was allocated through the Integrated Care Fund (ICF) to stimulate the delivery of regional residential services. Liaison with RPBs continues to formally monitor progress and timelines for the establishment of the new residential units.
25	Strengthen public bodies in their role as 'corporate parent'.	A Corporate Parenting Implementation Group has been established to strengthen corporate parenting within local authorities and widen responsibilities across the public sector. It has focused on the development of a Corporate Parenting Charter, which is being finalised.

26	Deliver the Young Persons Guarantee, giving everyone under 25 the offer of work, education, training, or self-employment.	The Young Person's Guarantee became operational from 30 September 2021, and between then and 31 March 2022, 2,727 young people needing additional support have accessed the service. Working Wales has launched a new service to help young people find employment opportunities, 52,463 jobs have been advertised, up to 31 March 2022.
27	Create 125,000 all-age apprenticeships.	Between May and October 2021, there were 10,385 apprenticeship starts. An Employer Incentive Scheme has been introduced dedicated to encouraging the recruitment of disabled people supporting both learners and employers post-pandemic. A new model for delivering Shared Apprenticeships has been established to support the expansion into new sectors and the recruitment of disadvantaged young people and under-represented groups.  Apprenticeship Commission Programme (ACP) contracts have been awarded which will run from 1 August 2021 to 31 July 2025.
28	Put social partnership on a statutory footing through the Social Partnership and Public Procurement (Wales) Bill.	We consulted on a draft Social Partnership and Public Procurement (Wales) Bill and published a summary of the responses in July 2021. The Bill was introduced in the Senedd in June 2022.
29	Use the new network of Disabled People's Employment Champions to help close the gap between disabled people and the rest of the working population.	The Disabled People's Employment Champions have engaged a range of organisations and businesses and worked closely with the Business Wales service. During 2021-2022, the Disability Support Service in Business Wales engaged with 286 businesses, providing advice to 162 clients. 103 businesses received advice to change policies and procedures and 44 businesses have made the Disability Confident Commitment.  The champions were crucial in ensuring that the Young Person's Guarantee and other employability programmes have been designed and implemented with an awareness of the barriers experienced by disabled people. Our employability programmes have been enhanced to ensure this cohort will receive the individualised support required to enter sustainable employment. The employment outcomes for this cohort increased from 13% to 19% between 2020/21 – 2021/22.
30	Strengthen our Economic Contract.	The Economic Contract has been strengthened by updating the four pillars to reflect our priorities of economic strength and adaptability; fair work; promotion of wellbeing; and low carbon and climate resilience. Businesses we support now need to demonstrate current practice and make three to five commitments that further contribute to each of the pillars.
31	Support the Wales TUC proposals for union members to become Green Representatives in the workplace.	Additional funding has been provided to support the upskilling of trade union representatives to take on the Green Representative role from April 2022.
32	Support the creation of a Community Bank for Wales.	Exploratory work undertaken by Cambria Cydfuddiannol Ltd. was supported by the Welsh Government and this led, in December 2021, to the Monmouthshire Building Society announcing its intention to develop its approach to delivering a community bank in Wales which will aim to provide everyday retail banking services in communities across Wales. Work is underway to develop a detailed business plan.

Each of these projects aims to contribute to net zero and deliver significant socio-economic benefits to Wales.
34	Enable our town centres to become more agile economically by helping businesses to work co-operatively, increase their digital offer and support local supply chains, including local delivery services.	Plans to support businesses to work together to improve their town centre are being developed. £800k over three years will support town centre businesses to use digital technologies in their future planning and marketing activities.
35	Seek a 30% target for working remotely.	The <i>Remote Working Strategy</i> was published in March 2022. The network of over 25 pilot hubs is now open.

36	Launch a new 10-year Wales Infrastructure Investment Plan for a zero-carbon economy.	The <i>Wales Infrastructure Investment Strategy</i> was published in December 2021, completing this commitment. The Strategy has a clear focus on making sure investments in infrastructure contribute to a zero-carbon economy.
37	Deliver the Digital Strategy for Wales and upgrade our digital and communications infrastructure.	<p>Progress has been made across the Digital Strategy's six mission areas.</p> <p>The Centre for Digital Public Services (CDPS) has built digital capability across Welsh public services by supporting exemplar digital transformation projects, delivering training and agreeing a set of Digital Service Standards.</p> <p>The importance of data sharing in effective decision-making has been demonstrated through the use of the shared public sector DataMapWales platform. Investment of £500,000 in the Wales Data Nation Accelerator project has supported a national programme of collaboration and innovation in higher education and the economy.</p> <p>The £20m Local Broadband Fund has supported local authorities and social enterprises to provide broadband connectivity to Welsh communities. To date, £12m in capital funding and £500,000 in revenue have been committed and the funding will support 10 communities across Wales to access fast and reliable broadband. The £56m full fibre roll-out has provided gigabit capable broadband to nearly 30,000 premises to date. During 2021-2022, the Access Broadband Cymru (ABC) scheme saw 390 applications from businesses, 2111 from residential premises and 10 from the third sector. The number of applications to the ABC scheme each has doubled from pre pandemic levels reflecting the need for connectivity over the last two years.</p>
38	Create a modern legislative basis for transport in Wales.	The White Paper <i>One Network, One Timetable, One Ticket</i> was published in March 2022 setting out plans to create a new legislative framework for bus services, creating a system capable of improving services and responding to the Climate Emergency.
39	Lift the ban on local authorities setting up new municipal bus companies.	This is covered in commitment 38.

A Taxi & Private Hire Vehicle White Paper is being developed following involvement with stakeholders from the taxi and private hire vehicle sector, local authorities and a range of interest groups.

A National Transport Delivery Plan is being developed with Transport for Wales which will outline the plans, projects and policies that will deliver against the modal shift and decarbonisation targets set out in the Wales Transport Strategy. A new Transport Performance Board has been established to oversee delivery of <i>Llwybr Newydd; the Wales Transport Strategy 2021</i> , and met for the first time in January 2022.
42	Build on the success of our concessionary travel scheme for older people and look at how fair fares can encourage integrated travel.	An evaluation of a range of options to make bus travel more accessible and affordable for all in the community has been commissioned in partnership with Transport for Wales. This will be informed by the results of a nationwide travel survey of over 1,500 people from across Wales and a detailed survey of people's views on the discounted travel schemes trailed in Cardiff and Newport.
43	Work towards our new target of 45% of journeys by sustainable modes by 2040, setting more stretching goals where possible.	A range of policies are being developed and implemented to reduce dependency on cars. This includes reviewing the Welsh Transport Appraisal Guidance to ensure alignment with the transport strategy, bus legislative reform including the publication of the White Paper in March, establishing the roads review panel, and a programme of investments in public transport, active travel, and low carbon transport.
44	Take forward the Burns Commission report for Newport.	The Burns Delivery Unit published its Annual Report in January 2022, setting out the progress made on the recommendations from the South East Wales Transport Commission. This includes securing £2.7m of UK Government funding to take forward further scoping of enhancements to the South Wales main Line.
45	Develop a new major routes fund to improve the attractiveness and biodiversity of areas alongside major transport routes in Wales.	A Strategic Road Network biodiversity plan will launch in late Summer 2022. The Major Routes Fund will build on this work.
46	Create a farm support system to maximise the protective power of nature through farming, recognising the needs of family farms in Wales & acknowledging ecologically sustainable local food production.	The government's response to the White Paper consultation on Agriculture in Wales was published in September 2021. Engagement continues with the farming community as part of the development of the Agriculture Wales Bill and the Sustainable Farming Scheme.
47	Introduce a transition period to the new farm support scheme, including continuing stability payments, beyond the current Senedd term.	In September 2021, the Basic Payment Scheme and Glastir contracts were extended until the end of 2023. This reinforces our commitment that there will be no cliff edge in funding. The Welsh Government is committed to implementing a period of transition towards the Sustainable Farming Scheme of the future. Stability payments will continue to be a feature of the Scheme throughout and beyond the current Senedd term.

49	Pursue devolution of powers needed to help reach net zero, including management of the Crown Estate in Wales.	Work is underway to develop the case for devolution of the Crown Estate in Wales. In the meantime, work continues with the Crown Estate to maximise the benefits from renewable energy in Welsh waters and beyond.
50	Work towards the establishment of an Environmental Governance Body, a statutory duty and targets to protect and restore biodiversity.	Guidance on the application of Environmental Principles in the development of policies and legislation have been developed as an interim measure to address the gap in applying Environmental Principles in Wales. The interim guidance is an internal document and was produced in collaboration with key stakeholders.  Since March 2021, an interim assessor has been in place to consider concerns raised about the functioning of environmental law in Wales. In the first twelve months the interim assessor received 21 submissions from the public.

The responses to the consultation on banning single use plastic items have been analysed and proposals have been discussed with a range of relevant stakeholders. This is informing the development of legislative proposals.
52	Introduce an extended producer responsibility scheme to incentivise waste reduction by businesses.	A consultation exercise been undertaken jointly with the other nations of the UK. The consultation response and the final design of the Extended Producer Responsibility scheme for packaging were published in March 2022.
53	Create a National Forest to extend from the North of Wales to the South.	In March 2022, a suite of Data Map Wales GIS mapping tools was launched, allowing individuals and communities to visualise what the National Forest will look like in their area.  In July 2021, the Woodland Investment Grant, awarded funding to 9 high quality projects and a further 15 projects have been awarded funding under the Community Woodland Scheme, in collaboration with the National Lottery Heritage Fund. The development of three Commemorative Woodlands in Wales to remember those who lost their lives to Covid-19 and the nation's resilience throughout the pandemic have been announced. The first phase of 'My Tree, Our Forest' offering the first 5,000 trees of the campaign to provide every household in Wales a free tree to combat climate change was launched in March 2022.

In February 2022, a new woodland creation planning scheme offering grants for new woodland creation and building a pipeline of new woodland projects was launched.  Funding of £1.5m is in place to run phase 2 of the Home Grown Homes project. NRW has also developed a number of proposals for alternative approaches to selling timber that could deliver higher social value.
55	Develop a Wales Community Food Strategy to encourage the production and supply of locally-sourced food in Wales.	Work on a Wales Community Food Strategy is currently focused on scoping, evidence gathering and engagement with stakeholders.

This followed the Law Commission's review report published in March 2022.</p> <p>Work continues with Task Force partners to provide a consistent approach to the current inspection regime. The inspections programme is significant and has identified maintenance works needed to ensure the stability of sites. £44.4m has been committed over the next three years to take forward this work.</p> <p>Work continues with partners including the UK space industry to improve the way tips are monitored.</p>
57	Introduce a Clean Air Act for Wales, consistent with World Health Organisation guidance and extend the provision of air quality monitoring.	Following the consultation on the White Paper for a Clean Air Bill the responses are being analysed, reviewed and discussed with the Cross Party Group on a Clean Air Act for Wales and a range of other relevant stakeholders to inform development of the Bill.
58	Designate a new National Park to cover the Clwydian Range and Dee Valley.	Natural Resources Wales (NRW) has revised and updated the guidance that will provide the framework to be followed during the formal assessment of the new National Park. 60	Uphold our policy of opposing the extraction of fossil fuels in Wales, both on land and in Welsh waters, using the powers available to us.	<p>The tools and guidance necessary to enable the Welsh Ministers to undertake their statutory duty to administer existing petroleum licences, to determine Coal Authority mining operation licences and to determine new Carbon Capture Usage and Storage (CCUS) appraisal and storage licences continue to be developed in consultation. Work also continues with the UK Government on reforming the legal remit of the Coal Authority.</p> <p>To support domestic ambitions and global responsibilities, Wales has joined a new global alliance of countries pledging to stop licensing oil and gas production in an effort to fight climate change. As a founding member of the Beyond Oil and Gas Alliance (BOGA), Wales will be working internationally to support a managed phasing out of oil and gas.</p>
61	Expand arrangements to create or significantly enhance green spaces.	<p>A development and design phase for the Nature Network Programme (NNP) has been delivered led by NRW. Delivery mechanisms for Year 1 of NNP (22/23) have been agreed with circa £13.3m allocated. Work is underway to refine the programme for years 2 and 3.</p> <p>Local Places for Nature (LPfN) invested £8.55M to fund over 300 projects in 2021/22. The Community Packages scheme has delivered 279 nature gardens, 117 food growing areas, 157 community orchards and planted 5000 trees. Local Nature Partnerships delivered extensive verge and mowing practice projects and 15 challenge fund projects and in total delivered 59 projects across Wales.
