The Welsh Ministers, as traffic authority for the relevant length of the A4042 trunk road, and in exercise of the powers conferred upon them by sections 14(1), (4) and (7), 84(1)(a) and (2) and 124(3)(b) of the Road Traffic Regulation Act 1984(1), make this Order.

The Welsh Ministers have consulted with the Chief Officer of Gwent Police and given public notice of their intention to make this Order in accordance with regulations 5(1) and 6(1) of the Secretary of State's Traffic Orders (Procedure) (England and Wales) Regulations 1990(2).

Title and commencement

1. The title of this Order is the A4042 Trunk Road (Pontypool Roundabout to Court Farm Roundabout, Torfaen) (50 mph Speed Limit) Order 202- and this Order comes into force on **** 202-.

2. Yn y Gorchymyn hwn—

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw—

- (a) unrhyw gerbyd sy’n cael ei ddefnyddio at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1);
- (b) unrhyw gerbyd sy’n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu’r llu awyr ac sy’n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchmynion aelod o luoedd arfog y Goron, sy’n aelod o’r lluoedd arbennig—
 - (i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy’n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu
 - (ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “y gefnffordd” yw cefnffordd yr A4042 Casnewydd i Amwythig;

ystyr “lluoedd arbennig” (“*special forces*”) yw’r unedau hynny o’r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

3. Ni chaiff neb yrru unrhyw gerbyd modur yn gyflymach na 50 milltir yr awr ar y darnau o’r gefnffordd a bennir yn yr Atodlen i’r Gorchymyn hwn.

Dirymu

4. Mae Gorchymyn Cefnffordd yr A4042 (Cylchfan Pont-y-pŵl i Gylchfan Court Farm, Torfaen) (Terfyn Cyflymder 50 mya Dros Dro) 2025(2) wedi ei ddirymu.

Interpretation

2. In this Order—

“exempted vehicle” (“*cerbyd esempt*”) means—

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(1);
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A4042 Newport to Shrewsbury trunk road.

Restriction

3. No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of the trunk road specified in the Schedule to this Order.

Revocation

4. The A4042 Trunk Road (Pontypool Roundabout to Court Farm Roundabout, Torfaen) (Temporary 50 mph Speed Limit) Order 2025(2) is revoked.

SCHEDULE

The length of the northbound carriageway of the trunk road that extends from a point 36 metres south of Pontypool Roundabout to its junction with the southern side of that roundabout.

The length of the northbound carriageway of the trunk road that extends from its junction with the north-eastern side of Pontypool Roundabout to a point 216 metres north-east of that roundabout.

The circulatory carriageway of Pontypool Roundabout.

The length of the southbound carriageway of the trunk road that extends from a point 45 metres south of its junction with the south-eastern side of Court Farm Roundabout to its junction with the north-eastern side of Pontypool Roundabout.

The length of the southbound carriageway of the trunk road that extends from its junction with the southern side of Pontypool Roundabout to a point 40 metres south of that roundabout.
