

**GORCHYMYN CEFNFFORDD YR A48
(CYLCHFAN CROSS HANDS I FOELGASTELL,
SIR GAERFYRDDIN) (CYFYNGIADAU
CYFLYMDER DROS DRO A DIM
GODDIWEDDYD) 2026**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A48, neu gerllaw iddi, rhwng Cross Hands a Foelgastell, Sir Gaerfyrddin.

Effaith y Gorchymyn yw gosod terfyn cyflymder dros dro o 50 mya, 40 mya neu 10 mya a gwahardd goddiweddud ar y darn o gefnffordd yr A48 sy'n ymestyn o'i chyffordd ag ochr ogledd-orllewinol Cylchfan Cross Hands hyd at ei chyffordd â'r ffordd sy'n arwain i Foelgastell. Dim ond pan fydd gwaith confoi yn digwydd y disgwylir i'r terfyn cyflymder o 10 mya fod yn gymwys.

Daw'r Gorchymyn i rym ar 22 Mehefin 2026. Disgwylir y bydd y gwaharddiadau a'r cyfyngiad dros dro yn weithredol yn ysbeidiol rhwng 20:00 o'r gloch ar y dyddiad hwnnw a 06:00 o'r gloch ar 2 Chwefror 2027, neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y cyfnod a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad am unrhyw waith ychwanegol a newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A48 TRUNK ROAD (CROSS HANDS
ROUNABOUT TO FOELGASTELL,
CARMARTHESHIRE) (TEMPORARY SPEED
RESTRICTIONS & NO OVERTAKING) ORDER
2026**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A48 trunk road between Cross Hands and Foelgastell, Carmarthenshire.

The effect of the Order is to impose a temporary 50 mph, 40 mph or 10 mph speed limit and prohibit overtaking on the length of the A48 trunk road that extends from its junction with the north-western side of Cross Hands Roundabout to its junction with the road leading to Foelgastell. The 10 mph speed limit is only expected to apply during convoy working.

The Order comes into force on 22 June 2026. The temporary restrictions and prohibition are expected to operate intermittently from 20:00 hours on that date until 06:00 hours on 2 February 2027, or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the period specified above, it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Notice of any additional works and changes to times and dates will be displayed before any rescheduled work begins.
