Thank you for your request which we received on 13/07/2026.

Information requested

You requested the following information relating to Penisarwaun Nursing Home:

1. Was asbestos identified in Penisarwaun Nursing Home during the relevant period or after? The relevant period being 1998 to 2008
 - a. If yes, please confirm what asbestos materials were identified (i.e. ceiling tiles / insulation products / floor tiles);
 - b. Were the asbestos materials removed from the building;
 - c. If so, when did the removal(s) take place;
 - d. Please confirm what asbestos materials (see 1.a), were removed?
2. Copies of all inspection / care and compliance reports relating to Penisarwaun Nursing Home from 2000 to 2018, regardless of whether they contain any reference to asbestos.

Our response

We have considered your request under the Freedom of Information Act 2000.

We have carried out a search of any records we hold in relation to Penisarwaun Nursing Home in order to establish whether any information captured by your request is held.

During the relevant period noted in your request, 1998-2008, 'Penisarwaun Nursing Home' was registered with CIW from 2002 when CIW took over the regulation of care homes, until 2009 when it was voluntary cancelled. Under our retention policy, we no longer hold any records for this registration of the home and so we hold no records relating to the relevant period noted in your request.

The property was then re-registered with CIW in 2009, as 'Penisarwaun Care Home'. This registration subsequently voluntary cancelled in 2019. We hold only limited records now for this registration of the home.

We have checked those remaining records for Penisarwaun Care Home and found no information held in relation to asbestos at the property.

We do still hold inspection reports for Penisarawaun Care Home, from 2015 onwards only. The inspection reports detail any non-compliance identified as part of the inspection, where applicable. These inspection reports are enclosed as follows:
