Please see response to questions below:

* Highways - these are the figures shared with SNP on the 17/02/25:

Average Vehicles broken down into three categories, based on an average day, this will naturally be lower on week days and weekends, but cautious to keep this as average.

- o Cars (e.g. VW Golf, VW Caddy) - 33 / Day
- o Small Vans (e.g. VW Transporter) - 35 / Day
- o Big Vans (e.g. Transit LWB) - 11 / Day

These figures are taken from a survey of vehicles during weekends over summer period, therefore will be our maximum numbers as rider numbers drop in winter (Oct - Feb).

* PROW - please find attached map which we have discussed and agreed with the PROW officer at Snowdonia National Park. The expectation is to install signage and look to replace the pipe crossing identified on map. Alongside this we have developed a Specific Risk Assessment identifying controls which I have attached for your reference.

* Uplift Vehicles - We have completed a mitigation plan middle of last year after consultation with the neighbors, which I have attached, we normally consult them every April/May to discuss any concerns and if requested by them during the year. Our mitigation plan has been developed around the discussion with the neighbors and to reduce our impact within our operational constraints.

* Cafe - Currently the Cafe sells Hot/Cold food (breakfast and Lunch), along with snacks and hot/cold drinks. The Shop sells Dyfi Bike Park and Sponsors merchandise along with bike parts.
