The Welsh Ministers, in exercise of their powers under section 247 of the Town and Country Planning Act 1990(1), make this Order.

Title and Commencement

1. Enw'r Gorchymyn hwn yw Gorchymyn Cau Priffyrdd (Tir a Elwid Gynt yn The Open Hearth, Hendre Farm Drive, Casnewydd) 2026 a daw i rym ar 28 Awst 2026.

1. The title of this Order is the Stopping Up of Highways (Land formerly known as the Open Hearth, Hendre Farm Drive, Newport) Order 2026 and it comes into force on 28 August 2026.

Dehongli

Interpretation

2. Yn y Gorchymyn hwn—

2. In this Order—

ystyr “y Cyngor” (“the Council”) yw Cyngor Dinas Casnewydd;

“the Council” (“y Cyngor”) means Newport City Council;

ystyr “y datblygwr” (“the developer”) yw'r person sy'n gwneud y datblygiad y mae'r caniatâd cynllunio wedi ei roi ar ei gyfer;

“the deposited plan” (“y plan a adnewydd”) means the plan entitled “The Stopping Up of Highways (Land formerly known as the Open Hearth, Hendre Farm Drive, Newport) Order 2026” with reference qA2429638 which accompanies this Order;

ystyr “Deddf 1990” (“the 1990 Act”) yw Deddf Cynllunio Gwlad a Thref 1990;

ystyr “y plan a adneuwyd” (“the deposited plan”) yw’r plan sy’n dwyn yr enw “Gorchymyn Cau Priffyrdd (Tir a Elwid Gynt yn The Open Hearth, Hendre Farm Drive, Casnewydd) 2026” o dan y cyfeirnod qA2429638 sy’n dod gyda’r Gorchymyn hwn.

Cau Priffordd

3. Yn ddarostyngedig i erthyglau 4, 5, 6 a 7 o’r Gorchymyn hwn mae Gweinidogion Cymru yn awdurdodi cau’r darnau o briffordd a ddisgrifir yn Atodlen 1 i’r Gorchymyn hwn ac a ddangosir â llinellau sebra ar y plan a adneuwyd. Mae Gweinidogion Cymru wedi eu bodloni bod angen cau’r briffordd er mwyn gwneud y datblygiad yn unol â’r caniatâd cynllunio a roddwyd o dan Ran 3 o Ddeddf 1990 gan y Cyngor ar 13 Mawrth 2026 o dan y cyfeirnod 25/0700 ac a ddisgrifir yn Atodlen 4 i’r Gorchymyn hwn.

Priffordd Newydd

4. Rhaid creu, er boddhad rhesymol y Cyngor, y darnau newydd o briffordd a ddisgrifir yn Atodlen 2 i’r Gorchymyn hwn, sy’n briffordd i’w chynnal ar draul y pwr cyhoeddus at ddibenion Deddf Priffyrdd 1980(1). Y Cyngor fydd yr awdurdod priffyrdd sy’n gyfrifol amdani.

Priffordd y Gwneir Gwelliannau Iddi

5. Rhaid gwneud gwelliannau, er boddhad rhesymol y Cyngor, i’r darn o briffordd a ddisgrifir yn Atodlen 3 i’r Gorchymyn hwn, sy’n briffordd i’w chynnal ar draul y pwr cyhoeddus at ddibenion Deddf Priffyrdd 1980. Y Cyngor fydd yr awdurdod priffyrdd sy’n gyfrifol amdanynt.

Y Darpariaethau sy’n Angenrheidiol neu’n Hwylus cyn Cau Priffordd

6. Ni chaniateir cau’r darnau o briffordd a ddisgrifir yn Atodlen 1 i’r Gorchymyn hwn—

- (a) hyd nes y bydd y datblygwr wedi darparu, er boddhad rhesymol y Cyngor, blaniau sy’n dangos sut y mae’r darnau o briffordd i’w cau;
- (b) hyd nes y bydd y datblygwr wedi darparu’r darn newydd o briffordd a ddisgrifir yn Atodlen 2 i’r Gorchymyn hwn er boddhad rhesymol y Cyngor;
- (c) hyd nes y bydd y datblygwr wedi gwella’r darn o briffordd a ddisgrifir yn Atodlen 3 i’r Gorchymyn hwn er boddhad rhesymol y Cyngor;

“the developer” (“y datblygwr”) means the person carrying out the development for which the planning permission has been granted; and

“the 1990 Act” (“*Deddf 1990*”) means the Town and Country Planning Act 1990.

Stopping Up

3. Subject to articles 4, 5, 6 and 7 of this Order, the Welsh Ministers authorise the stopping up of the lengths of highway described in Schedule 1 to this Order and shown by zebra hatching on the deposited plan. The Welsh Ministers are satisfied that the stopping up is necessary to enable development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by the Council on 13 March 2026 with reference 25/0700 and described in Schedule 4 to this Order.

New Highway

4. There must be created, to the reasonable satisfaction of the Council, the new lengths of highway described in Schedule 2 to this Order, which is to be highway maintainable at the public expense for the purposes of the Highways Act 1980(1) and the Council is to be the highway authority responsible for this.

Improved Highway

5. There must be improvements made, to the reasonable satisfaction of the Council, to the length of highway described in Schedule 3 to this Order, which is highway maintainable at the public expense for the purposes of the Highways Act 1980 and the Council is to be the highway authority responsible for these.

Provisions Necessary or Expedient before Stopping Up

6. The lengths of highway described in Schedule 1 to this Order must not be stopped up until—

- (a) the developer has provided, to the reasonable satisfaction of the Council, plans showing how the lengths of highway are to be stopped up;
- (b) the developer has provided the new lengths of highway described in Schedule 2 to this Order to the reasonable satisfaction of the Council;
- (c) the developer has improved the length of highway described in Schedule 3 to this Order to the reasonable satisfaction of the Council;

- (e) hyd nes y bydd y Cyngor wedi ysgrifennu at y datblygwr i gadarnhau bod paragraffau (a), (b), (c) a (d) wedi eu bodloni.

Ymgwymerwyr Statudol

7. Pan fo gan ymgwymerwyr statudol gyfarpar o dan y briffordd, ynddi, arni, drosti, ar ei hyd neu ar ei thraws yn union cyn dyddiad cau'r darnau o briffordd a ddisgrifir yn Atodlen 1 i'r Gorchymyn hwn, bydd gan yr ymgwymerwyr yr un hawliau mewn cysylltiad â'r cyfarpar ag a oedd ganddynt cyn cau'r briffordd.

Llofnodwyd ar ran y Dirprwy Weinidog dros Drafnidiaeth, yn gweithredu o dan awdurdod y Gweinidog Cabinet dros Fenter, Cysylltedd ac Ynni, un o Weinidogion Cymru.

- (e) the Council has confirmed in writing to the developer that paragraphs (a), (b), (c) and (d) are satisfied.

Statutory Undertakers

7. Where immediately before the date on which the lengths of highway described in Schedule 1 to this Order are stopped up, there is apparatus under, in, on, over, along or across the highway belonging to statutory undertakers, the undertakers continue to have the same rights in respect of the apparatus as they had before the stopping up.

Lengths of highway to be stopped up

1. An irregular shaped length of highway located in the parking area at the end of Hendre Farm Drive, Newport NP19 9LH, with an area of 45 square metres, labelled "A", and marked with zebra hatching on the deposited plan.
2. An irregular shaped length of highway located in the parking area at the end of Hendre Farm Drive, Newport NP19 9LH, with an area of 353 square metres, labelled "B", and marked with zebra hatching on the deposited plan.

A rectangular shaped length of highway located on the land previously known as the Open Hearth, Hendre Farm Drive, Newport NP19 9LH, measuring 7.5 metres at its widest point and 57 metres at its

Creation of a new residential development including the erection of 32 units, access, car parking, engineering, landscaping and associated works.
