ATISN 27445 – Responsible Individuals for RISCA service providers

Thank you for your request which we received on 28/08/2026.

Information requested

Your request follows on from our response to a previous request for information (ATISN 27216) dated 26 August 2026. In this response, we confirmed that for RISCA service providers that are a body corporate, not a local authority, there are 71 designated Responsible Individuals who hold the role of 'similar officer' rather than director.

You have asked for the following information in relation to those 71 Responsible Individuals who hold the role of 'similar officer' for RISCA service providers that are a body corporate:

1. Of the 71 Responsible Individuals who hold the role of 'similar officer', how many also hold the position of Registered Manager?
2. The names of the registered provider companies the 71 Responsible Individuals who hold the role of 'similar officer' are associated with.
