

**GORCHYMYN CEFNFFORDD YR A470
(CILFAN I'R DE O ABERCANNID,
MERTHYR TUDFUL) (GWAHARDD
CERBYDAU DROS DRO) 2026**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A470, neu gerllaw iddi, ger Cylchfan Abercynon, Rhondda Cynon Taf.

Effaith y Gorchymyn fydd gwahardd dros dro pob cerbyd, ac eithrio'r rhai a ddefnyddir ar gyfer y gwaith, rhag mynd ar y darn o gilfan cefnffordd yr A470 tua'r de a leolir tua 2000 o fetrau (2km) i'r gogledd o Gylchfan Abercynon.

Disgwylir y bydd y Gorchymyn yn dod i rym am 00:01 o'r gloch ar 6 Medi 2026 ac y bydd yn parhau mewn grym hyd 23:59 o'r gloch ar 19 Medi 2026 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y cyfnod a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 6 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei roi cyn gwneud unrhyw waith a ailamserlennir.

**THE A470 TRUNK ROAD (LAYBY
SOUTH OF ABERCANNID, MERTHYR
TYDFIL) (TEMPORARY PROHIBITION
OF VEHICLES) ORDER 2026**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A470 trunk road near the Abercynon roundabout, Rhondda Cynon Taf.

The effect of the Order will be to temporarily prohibit all vehicles, other than those being used for the works, from proceeding on the length of the A470 trunk road southbound layby situated approximately 2000 metres (2km) north of Abercynon Roundabout.

The Order is expected to come into force at 00.01 hours on 6 September 2026 and remain in force until 23:59 hours on 19 September 2026 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to be in force during the period specified above, it will remain valid for a maximum period of 6 months, as a contingency, should the work need to be rescheduled, or consequential or other work is required. Notice of any changes to times and dates will be given before any rescheduled work begins.
