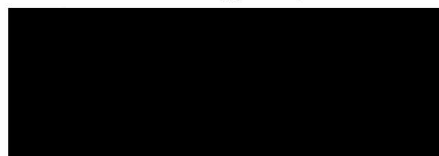

Planning Act (Listed Buildings and Conservation Areas) 1990

I refer to your letter dated 3 August 2001 and the numerous reminders received previously. I apologise for not informing you of the Planning Committee's decision in July 2000 to accept the officers' recommendation not to implement a listed building compulsory order and asking Cadw to remove the listed buildings status on the buildings,

The main reason for not responding to Cadw's reminders was the fact that they had all been written in English and this is contrary to the Council's policy of only accepting Welsh or bilingual letters from bodies in Wales.

I enclose a copy of the report presented to the Committee as well as the minutes for your attention and I would be pleased to receive your guidance about whether Cadw is willing to unlist the building and if so, how the work will be done.

I emphasise that it is not our intention to challenge Cadw's listings but a decision based on the value of the case and the fact that the owner has already received a heavy court fine for undertaking work without permission.

I would be pleased to receive your guidance on the application for unlisting.
