- (a) Local authority revenue expenditure is defined here as revenue expenditure 'on a total standard spending basis (TSS)'. It includes all revenue expenditure except that financed by local sales, fees and charges and certain specific grants, mainly those distributed by other government departments and external organisations. These excluded grants are known as being outside 'aggregate external finance' (AEF), which itself is central government funding for TSS. It excludes national parks' expenditure which is not available for earlier years.
- (b) The components do not add to the totals for technical reasons; these include rounding, authorities' use of balances and late adjustments to non-domestic rates bills, and payments of discretionary non-domestic rate relief.
- (c) Government grants include revenue support grant, council tax reduction scheme grant and specific grants within AEF, which is consistent with the financing of revenue expenditure.
- (d) Community charge was replaced by council tax in 1993-94. Community charge/council tax income includes income covered by benefit grant and as with revenue expenditure, amounts collected on behalf of community councils. Reductions financed by council tax reduction scheme grant are excluded, see footnote (c).
- (e) Service capital expenditure is defined as the total of gross capital expenditure for all services.
- (f) These include adjustments to expenditure incurred in one year but paid for in another year, and certain categories of revenue expenditure such as that for redundancy payments, against which The National Assembly for Wales has the power to issue a direction under section 40(6) of the Local Government and Housing Act, to permit local authorities to treat as capital expenditure.
- (g) Basic credit approvals are amounts announced by central government as permission to borrow to fund general capital expenditure.
- (h) Some basic credit approvals were replaced from 2000-01 by general capital grant, providing local authorities direct funding for general capital expenditure.
- (i) Supplementary credit approvals are amounts announced by central government as permission to borrow to fund specific capital projects.
- (j) Capital receipts earned from the sale of assets, repayments of grants and other sources may be used in part to fund specific capital expenditure. Some of these receipts must be set-aside for the repayment of debt.
- (k) Revenue resources can be transferred into the capital account to fund capital expenditure.

Some 120,000 separate price quotations are used each month in compiling the index. Caiff y RPI ei gyflwyno fel arfer ar ffurf mynegai sy'n dangos sefyllfa berthynol prisiau mewn perthynas â'r prisiau ym mis Ionawr 1987. Mae'r set ddata a gyflwynwyd yn rhoi'r cyfartaleddau blynyddol a seiliwyd ar y mynegeion misol hyn am y blynyddoedd ers 1987. Mae'r patrwm gwario y caiff y mynegai ei seilio arno yn cael ei adolygu bob blwyddyn a chaiff ei lunio gan ddefnyddio dewis helaeth a chynrychiadol o fwy na 650 o nwyddau a gwasanaethau y bydd y symudiadau yn eu prisiau yn cael eu mesur yn rheolaidd mewn oddeutu 150 o ardaloedd ledled y Deyrnas Unedig. Defnyddir rhyw 120,000 o wahanol ddyfyniadau prisiau bob mis wrth lunio'r mynegai.
