1. Completed by :-

- a. Operational station based FRS staff where station based firefighters undertake the main element of any provision even if some input is made by other FRS staff.
- b. Other FRS staff where staff other than station based firefighters undertake the main element of any provision.

Please provide a breakdown of how the Audits were conducted, whether they have been conducted as Telephone / Virtual Checks or whether Physical Visits to the premises have been undertaken. These totals should be equal to the total number of Home Fire Safety Checks completed by Fire and Rescue Station staff or other Fire and Rescue Services Staff as shown in Rows 1 and 2 in the table.

2. Total Number of Home Fire Safety Checks -

Count those completed (By telephone/virtual or in person at the premises) within the year between 01 April and 31 March, even if they were referred, requested, planned or even started before 01 April. Similarly, this total must not include any that were only started but not completed by 31 March, as these will be counted in a following year's totals of HFSCs completed. Where a HFSC has involved more than one visit, count only when the HFSC was considered to have been completed.

3. ... of which had been referred to the FRS

The number of HFSCs completed (as per the first column) that arose from a referral from another organisation under formal or informal collaborative arrangements between that organisation and the FRS.

4. ... of which had been requested

The number of HFSCs completed (as per the first column) that arose from a request to the FRS from e.g. the householder, neighbour, friend, family member, carer (not part of a formal referral arrangement). This would include, for example, requests to a freephone number, requests made at a stand at a show or eisteddfod.

5. ... of which had been instigated by the FRS

The number of HFSCs completed (as per the first column) that arose out of the FRS's own planning, campaigns, hotspotting activity, etc.

6. Total HFSCs completed where one or more risk factors where known to be present

A risk factor should be counted only where at least 1 member of the household is identified as displaying this risk. Risks may be identified as part of the referral process, as reported by the resident or as observed. Risks include:-

- Age where at least 1 resident was 65yrs+ on the day when the HFSC was completed
- Sensory or mobility impairment
- Mental health problem or learning difficulty
- · Alcohol or drug use/dependency.
- Smoking
- Single Adult present in the Household (including single parenthood)
- Domestic Violence
- Any other locally identified risk (eg rented accommodation)

Complete "1 risk factor" where only 1 of the risk factors above are known to be present, complete "2 risk factors" when only 2 of the risk factors are known to be present etc.

7. Total HFSCs completed that also involved completion of non-fire-related prevention activity

Completed in accordance with the FRS's own policies and procedures. E.g. checking for trip hazards or giving advice on security. Advice on arson reduction would not be included here as it would be considered fire prevention.

8. Total number of HFSCs that resulted in the FRS making an onward referral to another organisation.

Of the total in column 1, how many resulted in the FRS passing on the name and/or address to another organisation under a formal arrangement between that organisation and the FRS
